Category One – STERILIZING DITCH BOTTOMS

SP-104.01 CATEGORY ONE: STERILIZING DITCH BOTTOMS

This category of work includes sterilizing the ditch bottom by spraying approved herbicides in an appropriate and effective manner resulting in the eradication of all vegetation as described under the General Specifications and Special Provisions with regard to herbicide applications.

NOTE: Ohio River water levels can affect access to several regulated drains in Vanderburgh County, Indiana. Including, but not limited to:

Aiken Ditch – south east Vanderburgh County – Knight Township

Eagle Slough – south east Vanderburgh County – Knight Township

Barnett – south west Vanderburgh County – Union Township

Cypress Dale Maddox – south west Vanderburgh County – Union Township

Edmond – south west Vanderburgh County – Union Township

Helfrich Happe – south west Vanderburgh County – Union Township

Kamp – south west Vanderburgh County – Union Township

Successful Bidder must be aware of Ohio River levels and accomplish the awarded work during the designated time spans. Unusual elevated water levels as determined by the Surveyor exempted. Ohio River level at Evansville should be 20 feet or under for applications of herbicides. See National Weather Service Advanced Hydrologic Prediction Service at:

Please take extra care to eradicate the cattail infestations throughout the county.

An additional application of Category One MAY be added in August/September to help control creeping water primrose that was noticed in 2017 – this will be accomplished with a 14 day notice to the successful Bidder.

All herbicide applications within a category shall be completed within 14 (fourteen) calendar days of starting that category – in other words once the work is started it MUST be finished within 14 calendar days. Weather permitting.

Description of Work Area: The Regulated Drain that lies south of Morgan Avenue and South of the railroad from Green River Road east to the Vanderburgh / Warrick County Line and Nurrenbern and Stockfleth Ditches in their entirety. More particularly described as follows:

Hirsch Ditch beginning at Green River Road and continuing easterly to the intersection of Morgan Avenue and Burkhardt Road.

Kelly Ditch beginning at the Warrick County line on the South side of the Southern Railroad (South of and accessible from Morgan Avenue); thence Southwesterly under I-69 and to the intersection of Morgan Avenue and Burkhardt Road.

A significant infestation of cattails has occurred in Stockfleth Ditch north of Vogel Road. The successful Bidder shall take extra care in spraying for the eradication of cattails. If sufficient kill is not obtained, the Contractor may be called to make another application.

NOTE: In 2017 creeping water primrose was discovered in portions of these drains. An additional application MAY be added in August/September based on the growing season. The Contractor will be paid at the same rate for additional application with a 14 day notice from the Surveyor.

Category Two – BROADLEAF/BRUSH/GROWTH

SP-104.02 CATEGORY TWO: BROADLEAF HERBICIDES / BRUSH KILLERS / GROWTH INHIBITORS

Category Two covers the application of approved broadleaf herbicides (also known as foliar spraying or application), growth inhibiting chemicals, and/or approved brush killers to the side banks and top banks of drains in an appropriate and effective manner resulting in the eradication of all broadleaf and undesirable vegetation, and/or the inhibition of grass growth, if applicable, and all as described under the General Specifications with regard to herbicide applications. Coverage shall extend to five (5) feet from the top of banks. Except for applications made to Aiken Ditch south of the levee and Eagle Slough, which shall be twenty-five (25) feet from the top of banks in non-residential, non-cropland areas.

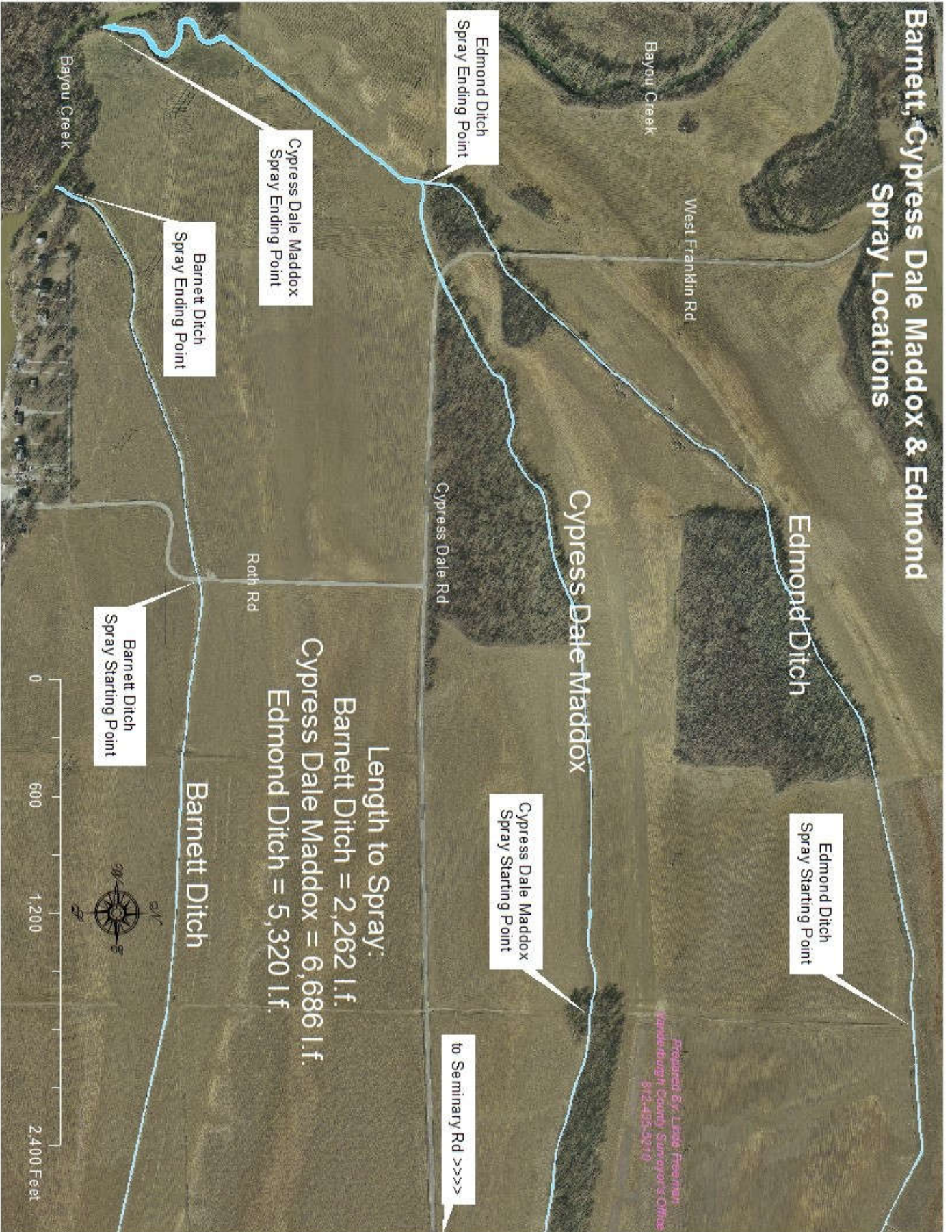

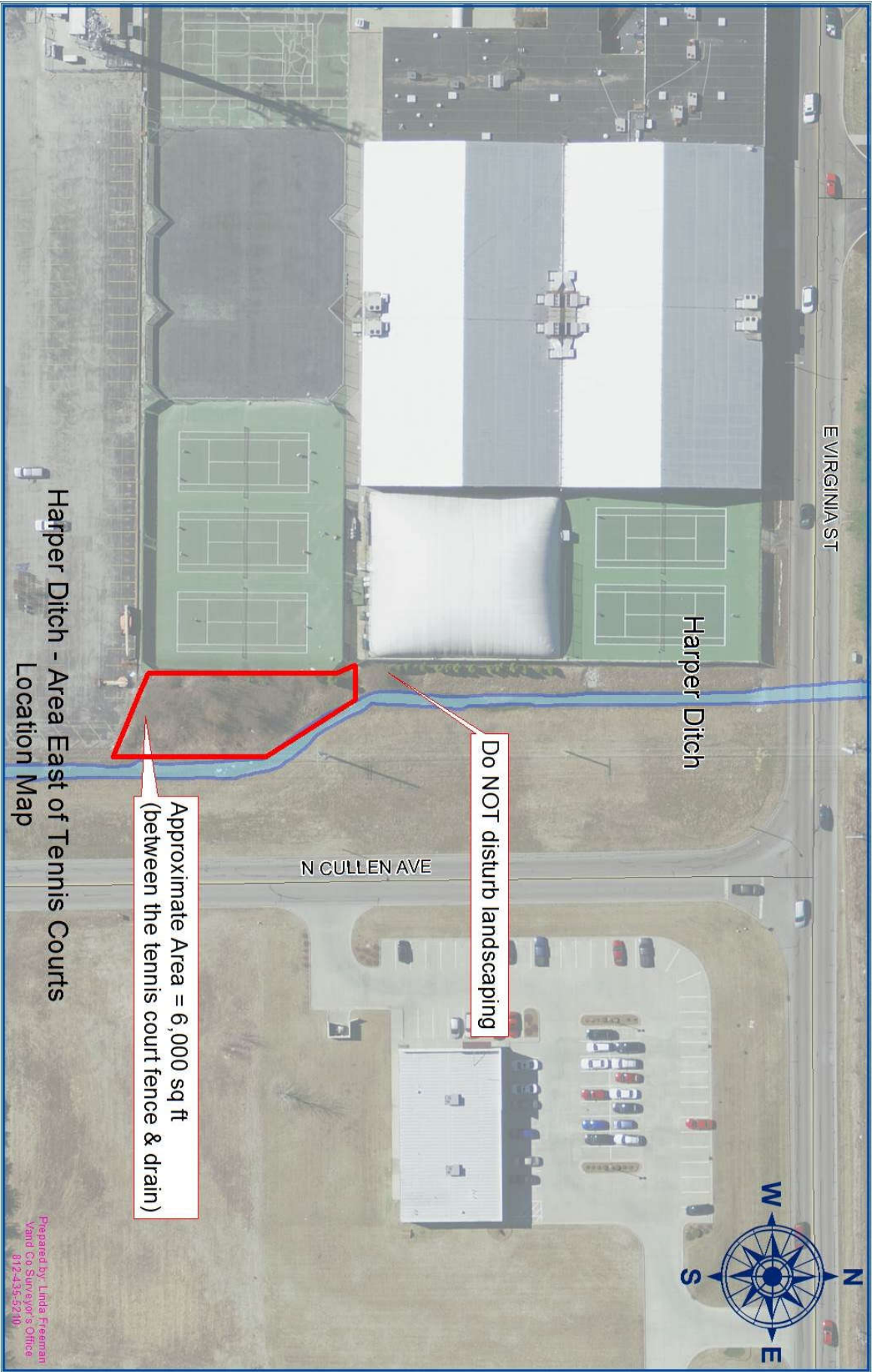
